As seen in the marked visa bulletin charts above, here are the major updates on the November 2022 Visa Bulletin:

### A. For final action dates for employment-based preference cases:

- The final action date for applications by those born in mainland China under the 'Other Workers' category was updated by 90 days from '01SEP12' to '01DEC12.'
- The final action dates for applications by those from El Salvador, Guatemala, and Honduras under the 'Certain Religious Workers' category was updated from 'Unauthorized' to '15MAR18.'
- The final action dates for applications by those from Mexico under the 'Certain Religious Workers' category was updated from 'Unauthorized' to '15SEP20.'

#### B. For dates for filing of employment-based visa applications:

No changes/updates were made.
