Curricular Practical Training (CPT)

Curricular Practical Training (CPT) allows F Visa students to work and gain work experience through employment training and paid internship programs directly related to their major area of study.

Day 1 CPT

Generally, F Visa students have to study a program for more than one year before they are allowed to engage in CPT. However, those who have already completed a program in the U.S. may bypass this requirement. This makes Day 1 CPT possible.

CPT Conditions

- **CPT must be integral to your major and the experience must be part of your program of study.**
- **For Day 1 CPT in graduate levels, designated school officials (DSO) may authorize CPT during the first semester if the program requires this type of experience.**
- **CPT requires a signed cooperative agreement or a letter from the employer.**

CPT Conditions

- **You can work on CPT either full-time or part-time.**
- **If you have 12 months or more of full-time CPT, you are ineligible for OPT, but part-time CPT will not impact your OPT.**

CPT Eligibility

Designated School Officials (DSOs) have the right to determine the Day 1 CPT eligibility of the students. It is up to the university to determine if any of its programs need to be paired with a Day 1 CPT option. It is also the university's responsibility to make sure their Day 1 CPT programs are in compliance with all the USCIS regulations.

Requirements for Schools

- **Designated school official (DSO) authorization of CPT on the student's Form I-20, Certificate of Eligibility for Nonimmigrant Student Status.**
- **Authorization by DSO should be based upon finding that the CPT is an integral part of an established curriculum.**
- **Statement that the authorized CPT is an integral part of the student's program.**
- **CPT agreement signed by the school and the employer.**

Requirements for Students

- **F-1 (full-time student) status;**
- **CPT job offer;**
- **CPT job description should be closely related to enrolled program;**
- **CPT application should be approved by DSO with CPT I-20;**
- **Throughout CPT, you should maintain GPA at or above 3.0;**
- **Part-time CPT is 20hr/week;**
- **Full-time CPT is 40hr/week;**
- **If you used full-time CPT for 12 months, you will not be able to have OPT after graduation.**

Document List for Students

Secure the following while under CPT (you are required to present them when changing your status):

- Official transcripts issued by the school;
- Certificates issued to you showing courses completion;
- Receipts for tuition payment;
- Receipt for books, parking passes, and school supplies;
- Your student ID;
- Your course list and syllabi;
- Info about your program;
- Evidence showing that you have attended the courses including transportation receipts, tickets, and attendance records;
- Your US residence's utilities bills, rental contracts, and rent payment receipts;
- Online education class credits you are enrolled for each session, term, and semester;
- Name and code of the courses which you are enrolled that require CPT;
- Document as evidence that CPT is required for your study; and
- Statement from the school that CPT is an integral part of your program.

Application Process

Step 1

Get an offer from accredited Day 1 CPT University. By this time, it is ideal that you should already have a job offer from your intended CPT job.

Step 2

Complete SEVIS Transfer to enable CPT university to issue new I-20.

Step 3

Upon payment of tuition fee, enroll to selected course which curriculum requires CPT.

Application Process

Step 4

Apply for CPT according to school guidelines. Submit your offer letter, and a CPT agreement signed by your employer along with other supporting materials required by your university to apply for a new CPT I-20.

Step 5

Wait for your CPT application to be approved by your CPT school and receive your new I-20. You are not allowed to work until you receive your new I-20.

Problematic CPT

A problematic CPT might result to serious consequences, which impact changing or extending your status in the future. Such record also triggers denial of your visa application.

Signs of a Problematic CPT

- **If all you need to do is to pay the tuition;**
- **If you are never required to attend any classes;**
- **If there are no regular campus, staff, and teaching activities; and**
- **If anyone in the same program was denied a change of status due to participating in the program.**

What is a Legit CPT?

- **If you are enrolled in a legitimate CPT program and you have to attend discussions and maintain good standing;**
- **If your CPT is authorized by the DSO;**
- **If you keep your I-20 updated;**
- **If the school has a good partnership with the CPT job; and**
- **If the program has a good track record in terms of previous successful CPT's.**
